

Dear CDA Members,

December first begins the Season of Advent. This is meant to be a season we prepare spiritually for the second coming of Christ and for remembering his first coming on earth. It seems to me that message and celebration of Advent almost gets lost with all the hustle and bustle of preparing for Christmas. There seems to be so much to do: picking out the Christmas tree, decorating, shopping, arranging for travel, planning the Christmas



meal, various parties to attend and watching the endless Christmas T.V. shows that seldom have anything to do with Jesus Christ who is the center of Christmas. It is so easy to get distracted by all these extrinsic that we can easily miss the heart of the Advent season and its wonderful message that the Christ, the Messiah, has come to save us and will come again to take us to our heavenly Father. The world have us ignore the Advent season, pushes us toward sales and obtaining more "things" so we can have a "Merry Christmas" or should I say a Happy Holiday. It is tough to fight this onslaught from the world and to focus on the message and spirit of Advent.

What can we do to counter this oppressive badgering? I think we need to plan our Advent time, schedule our events so that we give proper attention to the Season of Advent as the Church envisions it. Make the decision to attend Mass daily or several times during the week. If that is not possible, take fifteen minutes to read the Scriptures of the daily Mass, reflect on and pray over them and see how they apply to your own life. Using the Advent wreath or calendar can lead to prayer and reflection. Or, each week of the four weeks of Advent read the Christmas story from one of the Gospels with your spouse so that over the season you have heard all four accounts of Jesus' birth. Make out a shopping list for the presents you wish to give and plan a day to shop rather than making multiple trips to stores and pray for those whom you are buying gifts asking God's blessings upon them. Maybe simplifying your decorations, postponing for a few weeks doing the decorating and give emphasis to the nativity scene as the central point of attention in your home. When decorating ask God to decorate your heart with a deepening love or service to others. As you prepare the Christmas meal, give thanks for the food you are preparing, for those who will share the meal and His guidance for your guests. Wear a purple ribbon as a reminder that it is the season of Advent helping you to focus and remember the "reason for the season" - JESUS CHRIST.

I am sure there are many other ways to keep Advent holy and centered on Christ and the above are just a few I have thought of for you to consider. If we can take the activities we do during Advent and add a little prayer, a reflective thought to it, then we can keep the SPIRIT of ADVENT.

Thank you for remembering our youth and providing for them as you do. This time around I'll share a little bit of what my own court does for youth in our community and then I'll share about what other courts are doing in future newsletters.

Court Caruana #906 of Yakima supported a new pilot program within their Juvenile Justice System / Gang Court.

They are providing graduation gifts to two former gang members that are now graduating from Gang Court, getting an education and staying out of trouble. They are also providing the means for some of the kids to pay for their GED testing fees. Court Caruana provides Rod's House (a sanctuary for homeless / disadvantaged teens) a full meal for 30 to 50 teens, 13 to 20 years old, once a month.

#### National / State Project Chair Profile and Report

I'm Marilyn Nagle from Walla Walla and I am the new State Chair for National & State Projects. I am retired but busier than ever. I have two grown children, 3 grandchildren and now I have Miss Alice my great granddaughter and what a delight she is!

My goal the next few years is to get a sharing of ideas going throughout the state. Many of you are doing great things in your communities. I encourage all of you to send me pictures of your events with a small write-up about the event. We would like to start featuring 3 to 4 courts and their ideas with each newsletter. So help me out by sending in pictures and write-ups.

Here is an idea that you can use to raise money for your local, state and/or national projects and charities.

Many of you may know that for the last four years, Christy Hall (your State Regent) and myself have been making pies and giving the profits to local charities in our community. We have donated \$13,600 in the last four years from just one idea that Christy got from Court Caruana in Yakima.

Court Caruana took one day, using their church kitchen made 100 pies, baked them (can you imagine how wonderful the church must have smelled) and sold them for \$10.00 each to people coming out of church. That's \$1,000 for just making pies in one day!

We took it one step farther. We made the pies, froze them (unbaked), then sold them frozen so you can bake them when you want one. So now your homes smells great. On a cold winter day who does not like an apple pie right out of the oven, and you did not have to go through the hassle and mess of making it. Yum!!! We have made apple, cherry, berry, rhubarb, pumpkin and mincemeat pies and frozen them with great success.

We sell our pies for \$12.50 each and have had no problem selling them at that price. The cost of material is always going up, so we try to get as much donated as possible (like apples, rhubarb, flour and sugar). We also started a spreadsheet to keep

track of names, numbers and the email addresses of our customers. This way we can call or email and have repeat customers. We have one lady that usually buys 18 at one time and several who buy 10 or 12 at a time (they treat themselves to one pie a month).

Now's the time to start thinking if this could work in your court. With the holidays coming, could you take a day to make pies to sell after church so everyone could have home-made pies for the holiday gettogethers? **HAVE FUN** and make lots of money for your projects and charities.

#### Our Lady of Guadalupe

Mesoamerica, the New World, 1521: The capital city of the Aztec empire falls under the Spanish forces. Less than 20 years later, 9 million of the inhabitants of the land, who professed for centuries a polytheistic and human sacrificing religion, are converted to Christianity. What happened in those times that produced such an incredible and historically unprecedented conversion?



In 1531 a "Lady from Heaven" appeared to a humble Native American at Tepeyac, a hill northwest of what is now Mexico City. She identified herself as the ever virgin Holy Mary, Mother of the True God for whom we live, of the Creator of all things, Lord of heaven and the earth. She made a request for a church to be built on the site, and submitted her wish to the local Bishop. When the Bishop hesitated, and requested her for a sign, the Mother of God obeyed without delay or question to the Church's local Bishop, and sent her native messenger to the top of the hill in mid-December to gather an assortment of roses for the Bishop.

After complying to the Bishop's request for a sign, She also left for us an image of herself imprinted Miraculously on the native's *tilma*, a poor quality cactus-cloth, which should have deteriorated in 20 years but shows no sign of decay 476 years later and still defies all scientific explanations of its origin. It apparently even reflects in <u>Her eyes</u> what was in front of her in 1531.

Her message of love and compassion, and her universal promise of help and protection to all mankind, as well as the <u>story of the apparitions</u>, are described in the "Nican Mopohua", a 16th century document written in the native Nahuatl language. There is reason to believe that at Tepeyac Mary came in her glorified body, and her actual physical hands rearranged the roses in Juan Diego's tilma, which makes this apparition very special.

An incredible list of miracles, cures and interventions are attributed to Her. Yearly, between 18 - 20 million pilgrims visit the <u>Basilica</u>, making it Christianity's most visited sanctuary. Altogether 25 popes have officially <u>honored Our Lady of Guadalupe</u>. His Holiness John Paul II visited her Sanctuary four times: on his first apostolic trip outside Rome as Pope in 1979, and again in 1990, 1999 and 2002.

The Feast of Our Lady of Guadalupe is celebrated on December 12th. In 1999, <u>Pope John Paul II</u>, in his homily from the Solemn Mass at the Basilica of Our Lady of Guadalupe, during his third visit to the sanctuary, declared the date of December the 12th as a Liturgical Holy Day for the whole continent. During the same visit Pope John Paul II entrusted the cause of life to her loving protection, and placed under her motherly care the innocent lives of children, especially those who are <u>in danger of not being born</u>.



Some courts raise money for medical items, for their parishes and for organizations like Catholic Relief Services and Habitat for Humanity.
