The Power of Intercessory Prayer

One of the things that we are called to do is pray on behalf of others. We do this because we have been touched deeply and profoundly by the love of God in Christ and we want everyone to experience the unfathomable riches we have in Him.

Because we live in a world where we have a lot of instant gratification and seek instant results for things, we can begin to grow weary and doubt the importance of praying on behalf of others. When we fail to see results we can begin to wonder if praying for others really makes that big of a difference. Have you ever stopped to think about how the Mass is faithfully offered for the "peace and salvation of all the world" (Eucharistic Prayer III) everyday throughout the world? Every time the Mass is offered we pray faithfully for the completion of Christ's mission to be brought about. This is a beautiful gift to the Church but we need to make it personal. To really pray along with the Mass means bringing what it means into our daily lives.

One of the ways I have experienced God's love is when people tell me that they are praying for me. I know my own weaknesses and to know that someone cares enough for me to pray for me that I might fulfill God's will faithfully each day brings great joy into my heart and I've always seen it as a sign of God's love for me. I too pray for the people God brings into my life and I have found it helpful to have a prayer list so that I can remember various needs and people who have asked for prayer. Part of our common ministry as the baptized is to share in the priesthood of Christ. Priests offered prayer and sacrifices on behalf of the people, so every baptized person is called to think and pray for others and to make sacrifices for them. It's a fundamental part of our basic Christian identity.

Do you know someone around you who is having a difficult time? Write their name down and spiritually adopt them by asking God's



protection and blessing for them. You will see that God will give you a real heart for his people and you will find little ways to express the love that God puts into your heart for your neighbors. Intercessory prayer prays for God's blessing and providence for others, but the amazing thing we discover is that our heart is touched and blessed also! By not putting ourselves first we experience grace and blessing and we share in the mission of the Church to further the Kingdom of God in our daily lives.

CDA First Vice State Regent—Profile

Be careful when Christy Hall asks you to do something! Here I am as the 1st Vice State Regent! I do appreciate the opportunity to serve. Most of you don't know me. I was born and raised a Catholic having lived in the Greenwood District, in North Seattle and graduated from Blanchet High School, 1966. My father was a member of the Knights of Columbus and various church organizations within our Parish of St. John's. My mother was a member of the Altar Society and Parish Mother's Club. I had never heard of Catholic Daughters. It wasn't until a new Court was to be established in the Spokane Valley, Court Madonna of the Valley that I had actually heard about Catholic Daughters. This was 2005. I was asked to join this group of women. I said yes without understanding the organization, its foundation or its mission. What was important to me was a local organization of Catholic Women who I perceived as interested in our Church as well as the



needs of individuals in the community. This seemed like a nice fit and it was important for me to have been asked!—to be included!

I am a retired social worker and administrator of adult day health care centers which have evolved over the past 35 years to provide socialization and health care services to impaired older adults to enable them to continue to live in their own homes. I have been very involved as a volunteer to assure that funding and resources are available for Seniors on both a National and State level. I have recently completed a six year term on the Washington State Council on Aging (advisory group to the Governor on Aging Issues) and served as its chair for the last two years. I continue to be involved locally with the Area Agency on Aging and serve on their advisory Board. In addition, I am involved in our local Parish, St. John Vianney in the Spokane Valley. My parents taught me the opportunity of giving back to our Church.

Recently, I spoke at two valley Catholic churches regarding Catholic Daughters. I was struck by a banner in the church which reads: **What do you want of me Lord, Where do you want me to serve!** This has been my motto for many years. I chose to be involved in Catholic Daughters because we are a group of Catholic Women who care about our faith and practice that faith through our involvement in the Church and Community—that is unity and charity.

Catholic Daughter's is an organization through which an individual can reasonably make a difference in today's world. An organization through which friends can be made and personal growth attained. It is an effective means through which we can serve our brothers and sisters along with serving God, church and country, by embracing the principle of faith working through love in the promotion of justice, equality, and the advancement of human rights and human dignity for all.

As the 1st Vice State Regent, I look forward to meeting many Catholic Daughters across the State. I want to hear from you about our organization, good and bad. Audrey Metcalf was voted in as Regent, with her friends Allena Surprenant as Vice Regent; Rita Surprenant as Secretary; and Kimberly Aoll as Treasur-

er. The girls are excited and proud as Court St. Therese, The Little Flower, will be installed in a formal ceremony on March 2, 2014, at the 12:00 Mass at St Mary Magdalen Church in Everett.

State Raffle

As I reflect on being a new State Officer, it is important for the officers to be involved and known by members throughout the State. This past year, Christy, our State Regent has traveled to many areas to meet with members to discuss Catholic Daughters and address issues the local Courts have. We have a very limited State Budget which does not allow for adequate reimbursement of expenses. This is an issue as we want to assure that we have good State Officers and not just those who can afford to cover their own expenses. Due to the need for additional funds for the State. our State Board has approved the following fund raiser. Sell 250 pre-numbered raffle tickets at \$20 per ticket. If all the tickets are sold, the proceeds are \$5000. (This could break down to each court in the state selling about 11 tickets.)

Our lawyer has been speaking to Mr. Guiliano from the IRS who advised her that due to our "integrated auxiliary" status under the United States Conference of Catholic Bishops, we do not need to file a Form 990. Do not respond to this letter, do not contact the gentleman who sent it to you, simply toss it in the trash! A Power of Attorney form was requested from every Court. It is to be sent to the National Office. The originals were sent, with a copy, to the attorney; an additional copy was retained for our files in the National Office. If anyone receives notice from their state government or from the IRS advising that their tax exempt status is being revoked, please forward those letter to the National Office. We will then send them directly to our attorney to have the status reversed. Thank you.

If all the tickets are sold, the State would then have a balance of \$3,000 towards state expenses. The drawing for the prizes would occur at the August Training Workshop. The State Board hopes you will support this fundraiser. If successful, we may not have to raise State dues.

A Note from Our National Representative

Greetings to all Washington Catholic Daughters. Hope you are enjoying some nice weather in Washington. It sure has been nasty here, but the weather has finally gotten a little better with the temperature hitting 30 today for the first time since before Christmas. In addition to the extreme cold, (we had 23 days where the temperature was below zero for at least part of the day), we have had two enormous blizzards that socked us in with snow so badly that the drifts were over 6 feet high in our driveway. Oh well, it is winter in Minnesota, what can I expect? I do have to say that the snow is beautiful but I am ready for spring and we are still at least a month away.

I attended the March for Life in Washington DC last month. Again it was a wonderful experience. It is so heart warming to see so many thousands of people at the March all standing up for Life. The Mass the night before was beautiful and Cardinal O'Malley's homily was excellent. In part, he compared the Right to Life movement to the young child in the story of "The Emperor's New Clothes." 
